

**INVITATIONS FOR BIDS (IFB)
LOCAL COMPETITIVE BIDDING**



1. The Government of India has received a loan from the Agence Francaise De Development towards the cost of **APFBC** project and intends to use a part of the funds to cover eligible payments under the contract for construction of works as detailed below. Bidding is open to all bidders from eligible source countries as defined in the IBRD *Guidelines for procurement*. Bidders from India should, however, be registered with the Government of **Assam** or other state Government/Government of India, or State/ Central Government Undertaking. **Bidders are advised to note the minimum qualification criteria specified in clause 4 of the Instructions to Bidders to qualify for the award of the contract.**
2. The PD, PMU, APFBC Society, invites bids for the construction of works detailed in the table. The bidders may submit bids for any or all of the following works, for the package or for any of the slices.
3. Bidding documents (and additional copies) may be purchased from the office of the Divisional Forest Officer, Sonitpur (East) Division from 18th to 31st July, 2014 for a non-refundable fee (three sets) as indicated, in the form of Demand Draft drawn on any Nationalized Bank payable in Guwahati in favour of the PD, PMU, APFBC Society. Interested bidders may obtain further information at the same address. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs 300/- (Three hundred) only. The Divisional Forest Officer concerned will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
4. Bids must be accompanied by security of the amount specified for the work in the table below, drawn in favour of The **Divisional Forest Officer, Sonitpur East Division**. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid.
5. Bids should be valid for **90** days after the deadline date specified for submission.
6. Bids must be delivered to **"Divisional Forest Officer, Sonitpur East Division, Biswanath Chariali"** as the case may be on or before **13.30** hours on 1st of August, 2014 and will be opened on the same day at **14.00** hours, in the presence of the bidders who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
