





8. Any savings out of the above sanctioned amount shall be refunded to the APFBC Society.
9. Separate Account shall be maintained for all expenditure of APFBC.
10. Reimbursement Claim under the Sanctioned Order shall be submitted to the PMU immediately after expenditure.
11. Under no circumstances funds specified against the submitted activities shall be diverted for any other purpose.
12. The items shall be used solely for the purpose that was sanctioned.
