- 9. Separate Account shall be maintained for all expenditure of APFBC.
- 10. Reimbursement Claim under the Sanctioned Order shall be submitted to the PMU immediately after expenditure.
- 11. Under no circumstances funds specified against the submitted activities shall be diverted for any other purpose.
- 12. The items shall be used solely for the purpose that was sanctioned.
